WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations. 2009. the National Council for Teacher Education has notified the Regulations. 2014 on 1.12.2014

- 2. AND WHEREAS, the institution, Farook Training College, Kozhikode 673632, Kerala has by affidavit consented to come under New Regulations and sought for three basic units in B.Ed. which require additional facilities.
- 3. AND WHEREAS, on scrutiny it is found that the institution has not has not shifted to its own premises as stipulated in its Formal Recognition order dated 13.07.2004
- 4. AND WHEREAS, it has been decided to permit the institution to have three basic units of students each subject to the institution fulfilling following conditions namely,
 - 1. The institution shall submit all documents including land, building, Encumbrance Certificate, Land Use Certificate, Building Plan, approved staff list, pertaining to shifting to own premises to the SRC before 31st July, 2015 failing which recognition will be withdrawn.
 - II. The Regional Committees shall inspect the proposed premises during August-September-October, 2015 and if on inspection it is found that the institution dose not fulfill required norms of infrastructure recognition will be withdrawn.
 - Furtner, with regard to the second unit the institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- IV. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015 Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- V. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017
- 5. NOW THEREFORE, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Farook Training College, Kozhikode 673632, Kerala for conducting B.Ed programme of two years duration with an annual intake of 150 for three basic units of 50 students each from the academic session 2015-16 subject to submission of revalidated FDRs of the enhanced value in joint account with the SRC before 30 June, 2015 and fulfilment of the conditions mentioned at II & III herein before 31.10.2015.

Further, the recognition is subject to fulfillment of other requirements as may be prescribed by ground the regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable

ORDER

As per Government Order read as 3rd paper above in implementation of the revised norms and regulations of NCTE 2014, the no. of intake for B.Ed courses in all existing Government Aided Training colleges are limited to one unit (50 seats) without cancelling any of the existing optional subjects and without reducing the existing staff strength and by creating essential posts. Now as per letters read as 2rd, 4^{rh},5^{rh},6^{rh} the concerned colleges requested to allow to continue the B.Ed & M.Ed courses in present conditions.

Government have examined the matter in detail and are pleased to accord sanction in principle to the following colleges.

- i) Mount Tabor Training College, Pathanapuram, Kollam and St. Joseph Training College for Women, Ernakulam which requires no further teaching posts other than that of Fine Arts & performing Arts are permitted to run total two unit B.Ed course (100 seats per year).
- ii) Farok Training College, Farok, Kozhikode and NSS Training College, Ottapalam, Palakkad which requieres one or two teaching posts other than that of Fine Arts & Performing Arts are permitted to run two unit B.Ed courses (100 seats per year) and one unit M.Ed course. (50 seats per year).

iii) NSS Training College, Changanassery and Sree Narayana Training College, Nedumganda. Thiruvananthapuram are having 7 & 6 optional subjects respectively. The NCTE regulations provides 8 teachers with 8 optional subjects. But for running the courses in these college(only 7 & 6 teachers respectively are necessary. Hence permission is given to these two college(sto run two units of B.Ed course without any creation of teaching post other than that of Fine Arts & Performing Arts subject to the permission from NCTE to conduct the course with one teacher per option.
