- A) First Party is a Higher Educational Institution named:

- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.
- E) SAFI Institute of Advanced Study, the Second Party is engaged in preparing schemes and plans to promote quality in all facets of education

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

### CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems/evaluation, keeping in mind the needs of the institute, the Second Party.

Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

### CLAUSE 2 SCOPE OF THE MoU

- 2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student and Teacher community to enhance their skills and knowledge.
- 2.2 **Skill Training:** The First Party also involve in Training Programs for the Teachers and students of second Party. The training and exposure provided to students and faculty through this association will build confidence and prepare the students and teachers to have a smooth transition from academic to working career.
- **2.3 Assessment and Grading:** The first Party will conduct or cooperate with the assessment and evaluation of the Teachers of the second party and if required certificate will also be issued.
- **Research and Development:** Both Parties have agreed to carry out the joint research activities in the fields of Education.
- 2.5 **Skill Development Programs:** Second Party to train the students of First Party on the emerging trends in order to bridge the skill gap and make them

- 2.6 **Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the new trends and in-house requirements if required.
- 2.7 **Faculty Development Programs:** First Party to train the Faculties of Second Party for imparting training as per the professional requirement considering the National Occupational Standards in concerned sector, if available.
- 2.8 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein
- 2.9 There is no financial commitment on the part of the SAFI Institute of Advanced Study, the Second Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealtseparately.

# CLAUSE 3 INTELLECTUAL PROPERTY

3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

#### CLAUSE 4 VALIDITY

4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period SAFI Institute of Advanced Study, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of Training Partner, the Second Party after

## RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
